Note regarding Limited English Proficiency (LEP):

In accordance with federal law, if there is a significant number of the population who are non-English speaking residents and are affected by the CDBG-MIT project, such citizens should have ‘meaningful access’ to all aspects of the CDBG-MIT project. To provide ‘meaningful access’, Grant Recipients may need to provide interpreter services at public hearings or provide non-English written materials that are routinely provided in English. Examples of such vital documents may include Citizen Participation notices (e.g., complaint procedures, hearings notices), civil rights notices, and any other published notice that may allow an eligible person with limited English proficiency to participate in discussing proposed CDBG activities.

PARTICIPATION PLAN

This plan is designed in accordance with the requirements of the Texas General Land Office Community Development Block Grant – Mitigation (CDBG-MIT) Program and Local Government Requirements found in found in 24 CFR §570.486 (Code of Federal Regulations).

Lubbock County encourages and will provide opportunities for citizen participation, particularly low-to-moderate income persons, and in the areas in which CDBG-MIT funds are proposed to be used.

Lubbock County will ensure that citizens are given reasonable and timely access to all local meetings (for example, all County Commissioners Court Meetings or Public Hearings will be posted at least 72 hours in advance), consistent with accessibility and reasonable accommodation requirements in accordance with Section 504 of the Rehabilitation Act of 1973 and the regulations of 24 CFR part 8, and the Americans with Disabilities Act and the regulations of 28 CFR parts 35 and 36, as applicable, as well as information and records relating to the actual use of CDBG funds.

Lubbock County is furnishing the following information pertaining to the proposed 2020 CDBG-MIT application for McMillian Dam:

- Available CDBG-MIT funds: The General Land Office of Texas has issued guidance that Lubbock County is eligible for up to \$10 million in CDBG-MIT funding related to the 2015 Flooding in Lubbock County.
- CDBG-MIT funding may be used for the following eligible activities:
 - Mitigation Activities
 - Construction
 - Activities addressing current or identified risks
 - Rehabilitation to existing structures
 - Risk Assessment
 - Professional Services
- Lubbock County is proposing an application to the GLO for eligible activities under the CDBG-MIT fund source that will benefit all residents of Lubbock County, of which 44.3 % are low-to-moderate income beneficiaries according to U.S. Census Data.

- The proposed CDBG/MIT activities in the 2020 CDBG-MIT grant application by Lubbock County are unlikely to displace any Lubbock County residents. All interruptions caused by construction are expected to be minimal and will primarily occur at or near McMillian Dam in Lubbock County. Should any displacement occur, Lubbock County will follow all local anti-displacement and relocation plans in accordance with 570.488.

Lubbock County will provide technical assistance to groups that are representative of low-to-moderate income residents that request assistance in developing proposals (including proposed strategies and actions to affirmatively further fair housing) in accordance with guidance provided by the State of Texas. Such assistance need not include providing funding to such groups.

Lubbock County will provide citizens with reasonable advance notice of, and opportunity to comment on, proposed activities in the CDBG-MIT application to the State of Texas, for grants already made, activities which are proposed to be added, deleted, or substantially changed from the entity's application to the State. "Substantially changed" means changes made in terms of purpose, scope, location or beneficiaries as defined by the criteria established by the State of Texas.

Lubbock County will accomplish the tasks outlined in this Participation Plan through one of the following methods:

- Posting of notice on Lubbock County's website;
- Publication of notice in the Lubbock Avalanche Journal;
- Notices prominently posted in public buildings (Such as the Lubbock County Courthouse) and distributed to local Public Housing Authorities or other interested community groups;
- Public Hearings; OR
- Individual notices to eligible cities and other entities as applicable using one or more of the following methods: Certified Mail, Electronic Mail or fax, First-class (regular) mail, Personal delivery (e.g. at Council of Governments meeting).

COMPLAINT PROCEDURES

Citizens can obtain a copy of these procedures at the County of LUBBOCK, 904 Broadway Street, Lubbock, Texas 79403 or 806-775-1000 during regular business hours.

Below are the formal complaint and grievance procedures regarding the services provided under the CDBG-MIT project.

1. A person who has a complaint or grievance about any services or activities with respect to the CDBG-MIT project, whether it is a proposed, ongoing, or completed CDBG-MIT project, may during regular business hours submit such complaint or grievance, in writing to the County Commissioner Jason Corley at 904 Broadway Street, Lubbock, Texas 79403 or may call 806-775-1000 .
2. A copy of the complaint or grievance shall be transmitted by County Commissioner Jason Corley to the entity that is the subject of the complaint or grievance and to the County Attorney within five (5) working days after the date of the complaint or grievance was received.

3. Lubbock County shall complete an investigation of the complaint or grievance, if practicable, and provide a timely written answer to person who made the complaint or grievance within ten (10) days.
4. If the investigation cannot be completed within ten (10) working days per 3 above, the person who made the grievance or complaint shall be notified, in writing, within fifteen (15) days where practicable after receipt of the original complaint or grievance and shall detail when the investigation should be completed.
5. If necessary, the grievance and a written copy of the subsequent investigation shall be forwarded to the CDBG-MIT for their further review and comment.
6. If appropriate, provide copies of grievance procedures and responses to grievances in both English and Spanish, or other appropriate language.

TECHNICAL ASSISTANCE

When requested, the County shall provide technical assistance to groups that are representative of persons of low- and moderate-income in developing proposals for the use of CDBG-MIT funds. The County, based upon the specific needs of the community's residents at the time of the request, shall determine the level and type of assistance.

PUBLIC HEARING PROVISIONS


For each public hearing scheduled and conducted by the County, the following public hearing provisions shall be observed:

1. Public notice of all hearings must be published at least seventy-two (72) hours prior to the scheduled hearing. The public notice must be published in a local newspaper. Each public notice must include the date, time, location, and topics to be considered at the public hearing. A published newspaper article can also be used to meet this requirement so long as it meets all content and timing requirements. Notices should also be prominently posted in public buildings and distributed to local Public Housing Authorities and other interested community groups.
2. When a significant number of non-English speaking residents are a part of the potential service area of the CDBG-MIT project, vital documents such as notices should be published in the predominant language of these non-English speaking citizens.
3. Each public hearing shall be held at a time and location convenient to potential or actual beneficiaries and will include accommodation for persons with disabilities. Persons with disabilities must be able to attend the hearings and the County must make arrangements for individuals who require auxiliary aids or services if contacted at least two days prior to the hearing per section 504 of the Rehabilitation Act of 1973, 24 CFR part 8 of the Americans with Disabilities Act and 28 CFR parts 35 and 36.
4. A public hearing held prior to the submission of a CDBG-MIT application must be held after 5:00 PM on a weekday or at a convenient time on a Saturday or Sunday.

5. When a significant number of non-English speaking residents can be reasonably expected to participate in a public hearing, an interpreter should be present to accommodate the needs of the non-English speaking residents.

The County shall comply with the following citizen participation requirements for the preparation and submission of an application for a CDBG-MIT project:

1. The County shall make available via public posting at the Lubbock County Courthouse (904 Broadway, Lubbock, Texas 79403) and the South Plains Association of Governments (1323 58th Street) and/or website posting (www.co.lubbock.tx.us) the substantially complete application to the GLO.
2. Lubbock County shall retain documentation of the notice(s), a listing of persons requesting additional information, all documents made available to the public and any other records concerning the proposed use of funds for three (3) years from closeout of the grant to the state. Such records shall be made available to the public in accordance with Chapter 552, Texas Government Code.
3. The posting shall include an opportunity to give citizens information as outlined in the applicable CDBG-MIT application manual to include, but is not limited to, the development of housing and community development needs, the amount of funding available, all eligible activities under the CDBG-MIT program, and the use of past CDBG-MIT contract funds, if applicable. Citizens, with particular emphasis on persons of low- and moderate-income who are residents of slum and blight areas, shall be encouraged to submit their views and proposals regarding community development and housing needs and be provided technical assistance in developing proposals. Citizens shall be made aware of the location, phone number and times where they may submit their complaints and grievances, and provide timely written answers to written complaints and grievances.
4. When a significant number of non-English speaking residents request information, an interpreter should be present or prepare documents in order to accommodate the needs of the non-English speaking residents.

Nota a los receptores de subvención en relación a requisitos de Dominio Limitado del Inglés:

De acuerdo con la ley federal hay un número significativo de población que son residentes y que no hablan inglés y son afectados por el proyecto CDBG-MIT, estos ciudadanos deben tener "acceso significativo" a todos los aspectos del proyecto CDBG-MIT . Para proporcionar "acceso significativo", receptores de la subvención pueden ser utilizados para proporcionar servicios de interpretación en las audiencias públicas o proporcionar materiales no escritos en inglés que se proporcionan de manera rutinaria en Inglés. Para obtener más información, consulte LEP.gov.

PROCEDIMIENTOS DE QUEJA

Estos procedimientos de queja cumplen con los requisitos del Departamento de Oficina General del Estatado federado de Texas Community Development Block Grant – Mitigation (CDBG-MIT) y los requisitos del gobierno local de Texas se encuentran en 24 CFR §570.486 (Código de Regulaciones Federales). Los ciudadanos pueden obtener una copia de estos procedimientos en la Condado de LUBBOCK, 904 Broadway Street, Lubbock, Texas 79403 (Dirección postal), 806-775-1000, (teléfono) en horario de oficina.

A continuación, se presentan los procedimientos formales de quejas y quejas relativas a los servicios prestados en el marco del proyecto CDBG-MIT.

1. Una persona que tiene una queja o reclamación sobre cualquiera de los servicios o actividades en relación con el proyecto CDBG-MIT, o si se trata de una propuesta, en curso o determinado proyecto CDBG-MIT, pueden durante las horas regulares presentar dicha queja o reclamo, por escrito a la Comisionar Jason Corley a 904 Broadway Street, Lubbock, Texas 79403(Dirección postal) o puede llamar a 806-775-1000(Teléfono).
2. Una copia de la queja o reclamación se transmitirá por el Comisionar Jason Corley a la entidad que es encargada de la queja o reclamación y al Abogado de la Condado dentro de los cinco (5) días hábiles siguientes a la fecha de la queja o dia que la reclamación fue recibida.
3. El Lubbock County deberá complir una investigación de la queja o reclamación, si es posible, y dara una respuesta oportuna por escrito a la persona que hizo la denuncia o queja dentro de los diez (10) días.
4. Si la investigación no puede ser completada dentro de los diez (10) días hábiles anteriormente, la persona que hizo la queja o denuncia sera notificada, por escrito, dentro de los quince (15) días cuando sea posible después de la entrega de la queja original o quejas y detallará cuando se deberá completar la investigación.
5. Si es necesario, la queja y una copia escrita de la investigación posterior se remitirán a la CDBG-MIT para su posterior revisión y comentarios.

6. Se proporcionara copias de los procedimientos de queja y las respuestas a las quejas, tanto en Inglés y Español, u otro lenguaje apropiado.

ASISTENCIA TÉCNICA

Cuando lo solicite, la Condado proporcionará asistencia técnica a los grupos que son representantes de las personas de bajos y moderados ingresos en el desarrollo de propuestas para el uso de los fondos CDBG-MIT. La Ciudad/Condado, en base a las necesidades específicas de los residentes de la comunidad en el momento de la solicitud, deberá determinar el nivel y tipo de asistencia.

DISPOSICIONES AUDIENCIA PÚBLICA


Para cada audiencia pública programada y llevada a cabo por la Ciudad/Condado, se observarán las disposiciones siguientes de audiencias públicas:

1. Aviso público de todas las audiencias deberá publicarse al menos setenta y dos (72) horas antes de la audiencia programada. El aviso público deberá publicarse en un periódico local. Cada aviso público debe incluir la fecha, hora, lugar y temas a considerar en la audiencia pública. Un artículo periodístico publicado también puede utilizarse para cumplir con este requisito, siempre y cuando cumpla con todos los requisitos de contenido y temporización. Los avisos también deben ser un lugar prominente en los edificios públicos y se distribuyen a las autoridades locales de vivienda pública y otros grupos interesados de la comunidad.
2. Cuando se tenga un número significativo de residentes que no hablan inglés seran una parte de la zona de servicio potencial del proyecto CDBG-MIT, documentos vitales como las comunicaciones deben ser publicados en el idioma predominante de estos ciudadanos que no hablan inglés.
3. Cada audiencia pública se llevará a cabo en un momento y lugar conveniente para los beneficiarios potenciales o reales e incluirá alojamiento para personas con discapacidad. Las personas con discapacidades deben poder asistir a las audiencias y el Condado debe hacer arreglos para las personas que requieren ayudas o servicios auxiliares si se contactan al menos dos días antes de la audiencia por la sección 504 de la Ley de Rehabilitación de 1973, 24 CFR parte 8 de la Ley de Estadounidenses con Discapacidades y 28 partes 35 y36 del CFR.
4. Una audiencia pública celebrada antes de la presentación de una solicitud CDBG-MIT debe hacerse después de las 5:00 pm en un día de semana o en un momento conveniente en sábado o domingo.
5. Cuando un número significativo de residentes que no hablan inglés se registra para participar en una audiencia pública, un intérprete debe estar presente para dar cabida a las necesidades de los residentes que no hablan inglés.


La Condado deberá cumplir con los siguientes requisitos de participación ciudadana para la elaboración y presentación de una solicitud para un proyecto CDBG-MIT:

1. Como mínimo, la Condado deberá tener por lo menos un (1) audiencia pública antes de presentar la solicitud al Departamento de Agricultura de Texas.
2. La Condado conservará la documentación de la convocatoria(s) audiencia, un listado de las personas que asistieron a la audiencia(s), acta de la vista(s), y cualquier otra documentación relativa a la propuesta de utilizar los fondos para tres (3) años a partir de la liquidación de la subvención para el Estado. Dichos registros se pondrán a disposición del público, de conformidad con el Capítulo 552, Código de Gobierno de Texas.
3. La audiencia pública deberá incluir una discusión con los ciudadanos como se indica en el manual correspondiente de aplicación CDBG-MIT, pero no se limita a, el desarrollo de las necesidades de vivienda y desarrollo comunitario, la cantidad de fondos disponibles, todas las actividades elegibles bajo el programa CDBG-MIT y el uso de fondos últimos contratos CDBG-MIT, en su caso. Los ciudadanos, con especial énfasis en las personas de bajos y moderados ingresos que son residentes de las zonas de tugurios y tizón, se fomentará a presentar sus opiniones y propuestas sobre el desarrollo de la comunidad y las necesidades de vivienda. Los ciudadanos deben ser conscientes de la ubicación en la que podrán presentar sus puntos de vista y propuestas en caso de que no pueda asistir a la audiencia pública.
4. Cuando un número significativo de residentes que no hablan inglés se registra para participar en una audiencia pública, un intérprete debe estar presente para dar cabida a las necesidades de los residentes que no hablan inglés.









RESOLUTION AND ORDER
ADOPTING LUBBOCK COUNTY'S HAZARD MITIGATION PLAN

WHEREAS, natural hazards in Lubbock County, Texas have historically caused significant disasters with loss of life and property and damage to natural resources; and

WHEREAS, the Federal Disaster Mitigation Act of 2000 (hereinafter referred to as "DMA 2000") and the Federal Emergency Management Agency (hereinafter referred to as "FEMA") require state and local governments to develop their respective Hazard Mitigation Plans that outline processes for identifying their particular natural hazards, risks and vulnerabilities; and

WHEREAS, Lubbock County acknowledges the requirements of Section 322 of DMA 2000 to have an approved Hazard Mitigation Plan as a prerequisite to receiving pre-disaster and post-disaster federal funding for mitigation purposes; and

WHEREAS, FEMA requires that jurisdictions then update their respective Hazard Mitigation Plans every five (5) years in order to be eligible for a full-range of pre-disaster and post-disaster federal funding for mitigation purposes; and

WHEREAS, Lubbock County sponsored the development of a county-wide FEMA Hazard Mitigation Plan; and

WHEREAS, Lubbock County, through the hazard mitigation planning process, has assessed Lubbock County's potential risks and hazards and has identified risk reduction strategies and actions for hazards that threaten the planning area; and

WHEREAS, the Lubbock County Hazard Mitigation Plan has been developed by the Lubbock County Office of Emergency Management, a department of Lubbock County, in cooperation with other Lubbock County departments, local municipalities, school districts, other planning partners and the citizens of Lubbock County; and

WHEREAS, the public involvement process consistent with the requirements of DMA 2000 was conducted to develop the Lubbock County Hazard Mitigation Plan; and

WHEREAS, the Lubbock County Hazard Mitigation Plan as developed recommends mitigation activities that will reduce losses of life and property affected by both natural and human-made hazards that face Lubbock County and its municipal governments, school districts and the citizens of Lubbock County;

NOW, THEREFORE, BE IT RESOLVED AND ORDERED BY THE COMMISSIONERS COURT OF LUBBOCK COUNTY, TEXAS:

1. That the Lubbock County Hazard Mitigation Plan is hereby adopted in its entirety as the official Hazard Mitigation Plan of this County;

2. That Lubbock County will pursue available funding opportunities for implementation of the proposals designated by the Hazard Mitigation Plan, and that Lubbock County will, upon receipt of such funding or other necessary resources, seek to implement the actions contained in the mitigation strategies therein;
3. That the Lubbock County Commissioners Court will be vested with the responsibility, authority and means to inform all requisite parties of this action; will assure that the Hazard Mitigation Plan will be reviewed on an annual basis at a minimum, and will assure that any needed adjustments to the Hazard Mitigation Plan will be presented to the Lubbock County Commissioners Court for consideration and approval as necessary;
4. That Lubbock County agrees to take such other actions as may be reasonably necessary to carry out the objectives of the Hazard Mitigation Plan and report on progress as required by FEMA and the Texas Division of Emergency Management (hereinafter referred to as "TDEM"); and
5. That the respective officials and agencies identified in the implementation strategy of the Lubbock County Hazard Mitigation Plan are hereby directed to implement the recommended activities assigned to them in said plan.



Mitigation – Local Certifications**

Each Applicant for Community Development Block Grant Mitigation ("CDBG-MIT") funding must complete Federal Assistance Standard Form 424 (SF-424) and certify that local certifications included in this application guide were followed in the preparation of any CDBG-MIT program application. Additionally, Applicant must certify that it will continue to follow local certifications in the event that funding is awarded and Applicant is reclassified as a Subrecipient.

Each Applicant/Subrecipient must comply with the provisions of the National Environmental Policy Act ("NEPA"), the Council on Environmental Quality ("CEQ") regulations, the requirements set forth in Title 24 of the Code of Federal Regulations ("CFR") part 58, and applicable Texas General Land Office policy directives.

Each Applicant/Subrecipient must comply with all applicable federal and state laws, including environmental, labor (Davis-Bacon Act), the procurement procedures and contract requirements found at 2 C.F.R. §200.318 – §200.326, and all civil rights requirements.

Each Applicant/Subrecipient certifies, as outlined in 84 FR 45838 (August 30, 2019), the following:

A. The Applicant/Subrecipient certifies that it has in effect and if following a residential anti-displacement and relocation assistance plan in connection with any activity assisted with CDBG-MIT funds.

B. The Applicant/Subrecipient certifies its compliance with restrictions on lobbying as required by 24 C.F.R. part 87, together with disclosure forms, if required by part 87.

C. Any entity or entities designated by the subrecipient, and any contractor, subrecipient, or designated public agency carrying out an activity with CDBG-MIT funds, possess(es) the legal authority to carry out the program for which it is seeking funding, in accordance with applicable HUD regulations and the federal register notice. The subrecipient certifies that activities to be undertaken with CDBG-MIT funds are consistent with the Action Plan.

D. The Applicant/Subrecipient certifies that it will comply with the acquisition and relocation requirements of the Uniform Relocation Act ("URA"), as amended, and implementing regulations at 49 CFR part 24, except where waivers or alternative requirements are provided for CDBG-MIT funds.

E. The Applicant/Subrecipient certifies that it will comply with Section 3 of the Housing and Urban Development Act of 1968 (12 U.S.C. §1701u) and implementing regulations at 24 C.F.R. part 135.

F. The Applicant/Subrecipient certifies that it is following a detailed citizen participation plan that satisfies the requirements of 24 CFR §91.115 or §91.105 (except as provided for in notices providing waivers and alternative requirements for this grant). Also, each local government receiving assistance from a state grantee must follow a detailed citizen participation plan that satisfies the requirements of 24 CFR §570.486 (except as provided for in notices providing waivers and alternative requirements for this grant).

G. The Applicant/Subrecipient certifies that it is complying with each of the following criteria:

1) Funds will be used solely for necessary expenses related to mitigation activities, as applicable, in the most impacted and distressed areas for which the President declared a major disaster in 2015, 2016, or 2017 pursuant to the Robert T. Stafford Disaster Relief and Emergency Assistance Act of 1974 (42 U.S.C. §5121 et seq.).

2) With respect to activities expected to be assisted with CDBG-MIT funds, the relevant action plan has been developed to give priority to activities that will benefit low- and moderate-income families.

3) The aggregate use of CDBG-MIT funds shall principally benefit low- and moderate-income families in a manner that ensures that at least 50 percent (or another percentage permitted by HUD in a waiver published in an applicable Federal Register notice) of the CDBG-MIT grant amount is expended for activities that benefit such persons.

4) The Applicant/Subrecipient will not attempt to recover any capital costs of public improvements assisted with CDBG-MIT funds by assessing any amount against properties owned and occupied by persons of low- and moderate-income, including any fee charged or assessment made as a condition of obtaining access to such public improvements, unless:

i. CDBG-MIT funds are used to pay the proportion of such fee or assessment that relates to the capital costs of such public improvements that are financed from revenue sources other than under this title; or

ii. For purposes of assessing any amount against properties owned and occupied by persons of moderate income, the grantee certifies to the Secretary that it lacks sufficient CDBG funds (in any form) to comply with the requirements of clause (a).

H. The Applicant/Subrecipient certifies that the grant will be conducted and administered in conformity with title VI of the Civil Rights Act of 1964 (42 U.S.C. §2000d), the Fair Housing Act (42 U.S.C. §3601-§3619), and implementing regulations, and that it will affirmatively further fair housing.

I. The Applicant/Subrecipient certifies that it has adopted and is enforcing the following policies, and, in addition, must certify that they will require local governments that receive grant funds to certify that they have adopted and are enforcing:

1) A policy prohibiting the use of excessive force by law enforcement agencies within its jurisdiction against any individuals engaged in nonviolent civil rights demonstrations;

2) A policy of enforcing applicable state and local laws against physically barring entrance to or exit from a facility or location that is the subject of such nonviolent civil rights demonstrations within its jurisdiction.

J. The Applicant/Subrecipient certifies that it (and any administering entity) currently has or will develop and maintain the capacity to carry out mitigation activities, as applicable, in a timely manner and that the subrecipient has reviewed the respective requirements of this notice.

K. The Applicant/Subrecipient certifies that it will not use CDBG-MIT funds for any activity in an area identified as flood prone for land use or hazard mitigation planning purposes by the state, local, or tribal government or delineated as a Special Flood Hazard Area (or 100-year floodplain) in FEMA's most current flood advisory maps, unless it also ensures that the action is designed or modified to minimize harm to or within the floodplain, in accordance with Executive Order 11988 and 24 C.F.R. part 55. The relevant data source for this provision is the state, local, and tribal government land use regulations and hazard mitigation plans and the latest-issued FEMA data or guidance, which includes advisory data (such as Advisory Base Flood Elevations) or preliminary and final Flood Insurance Rate Maps.

L. The Applicant/Subrecipient certifies that its activities concerning lead-based paint will comply with the requirements of 24 CFR part 35, subparts A, B, I, K, and R.

M. The Applicant/Subrecipient certifies that it will comply with environmental requirements at 24 CFR part 58.

N. The Applicant/Subrecipient certifies that it will comply with applicable laws.


