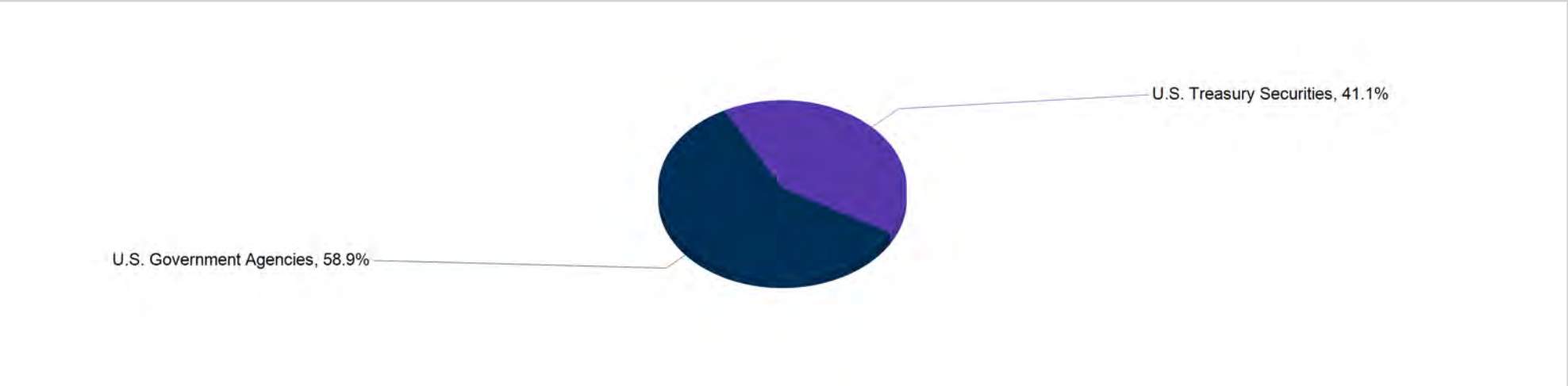

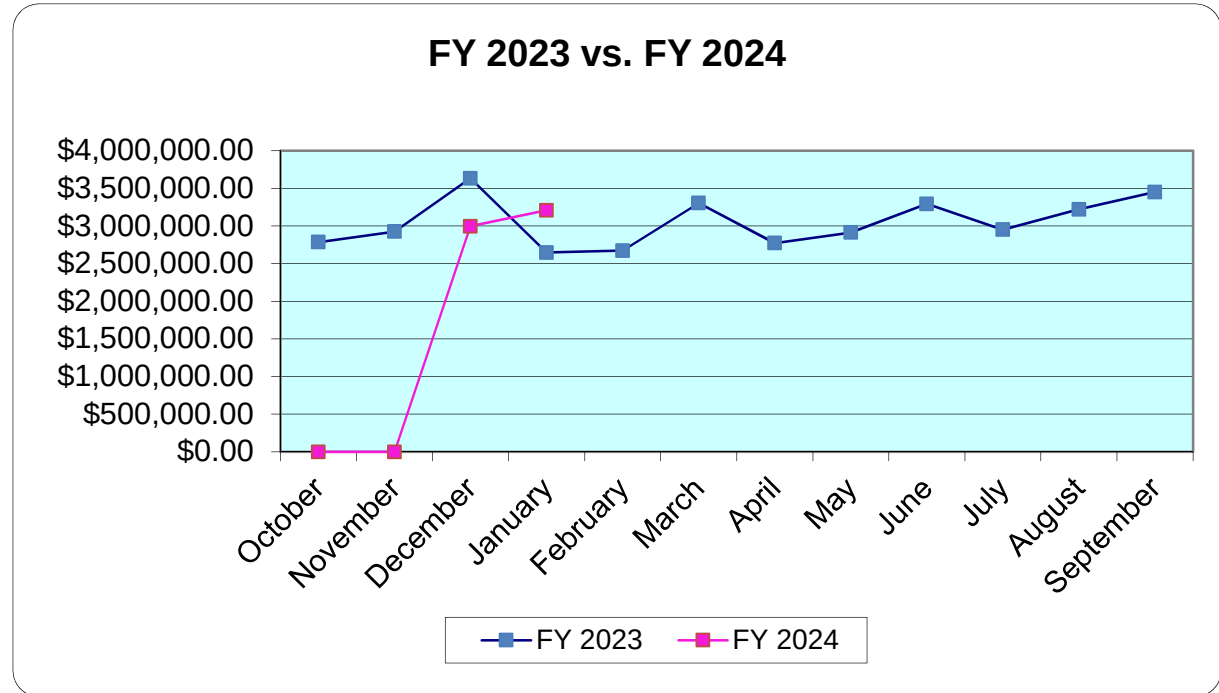

As of January 2024

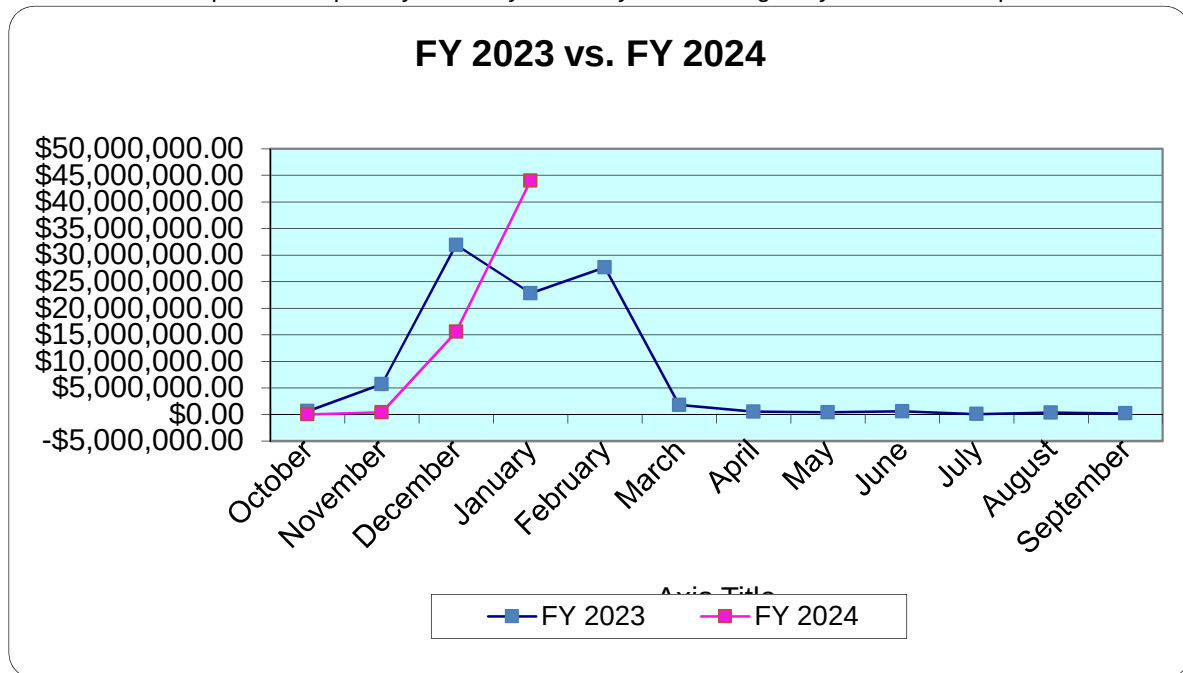
