The sale will be held at The gazebo located on the front lawn of the Lubbock County Courthouse with the first alternate location being the 2nd floor auditorium at 916 Main and the second alternate location being the Commissioner's Courtroom located on the 5th floor of the courthouse. The Secretary of Housing and Urban Development will bid an <u>estimate</u> of \$120,661.54.


