- 7. Financial update from the Lubbock County Auditor's office NONE
- 8. Update from Greg Garfield and Matt Edwards (Garfield Public Private), Randy Jordan (Lubbock County Expo Center, Inc.) and others regarding the Project. GREG STATED THAT THE RISK OF NOT EXTENDING THE BUILDING PERMIT IS VERY HIGH.
 CHAIRMAN GREENSTREET SAID AFTER VISITNG WITH THE MAYOR, WORK NEEDS TO BE DONE IN ORDER TO EXTEND THE BUILDING PERMITT. KIRK HEWITT FROM LEE LEWIS SAID IT WOULD COST \$3,900 TO DO THE WORK TO GET THE PERMIT EXTENDED AND THE TOTAL COST FOR WORK DONE IS \$28.000. NATALIE HARVIL SAID THE COUNTY HAS A CONTRACT WITH LEE LEWIS AND THE JUDGE HAS THE INVOICES ON HIS DESK. GREG SAID THAT THESE COST WILL BE PART OF THE OVERALL COST OF THE PROJECT. GREG IS WORKING ON AN UPDATED PRO FORMA THAT HE WILL PRESENT TO LOCAL BANKS FOR POSSIBLE FINANCING OF THE PROJECT.
