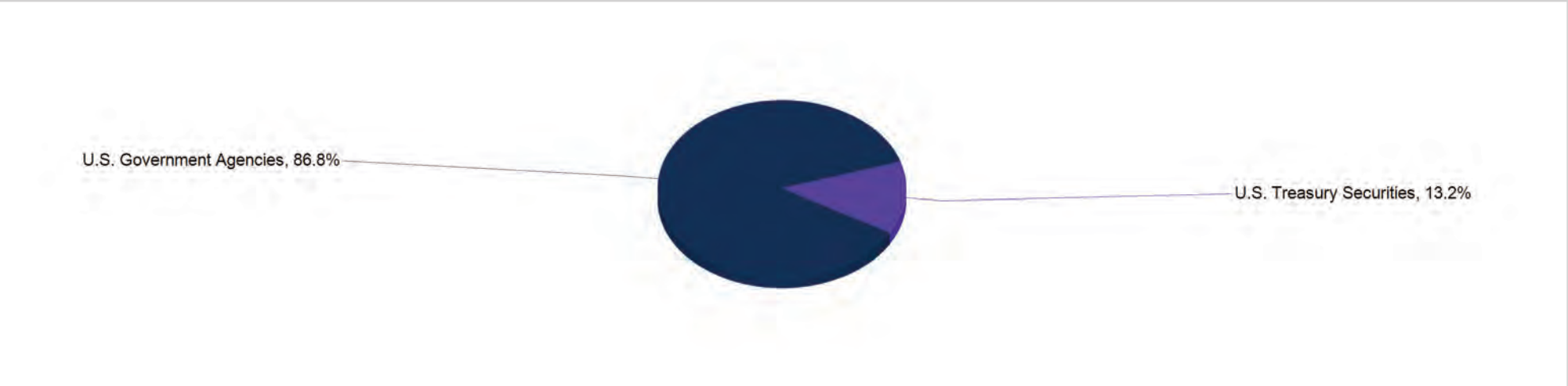

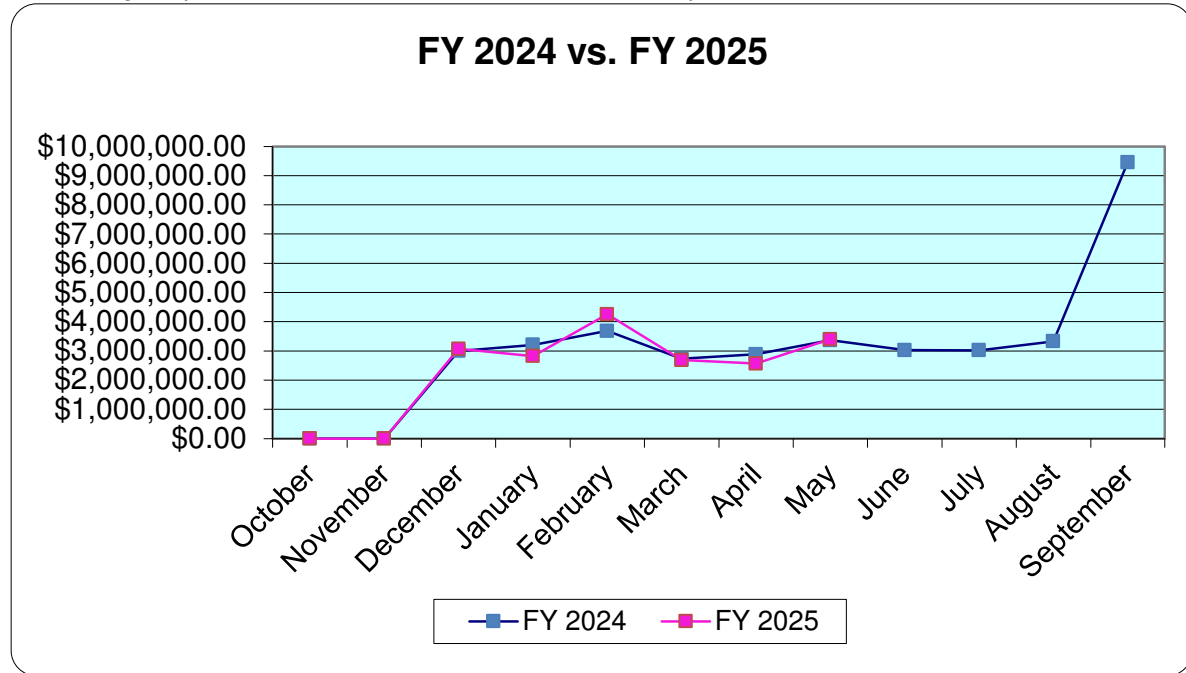

As of May 2025

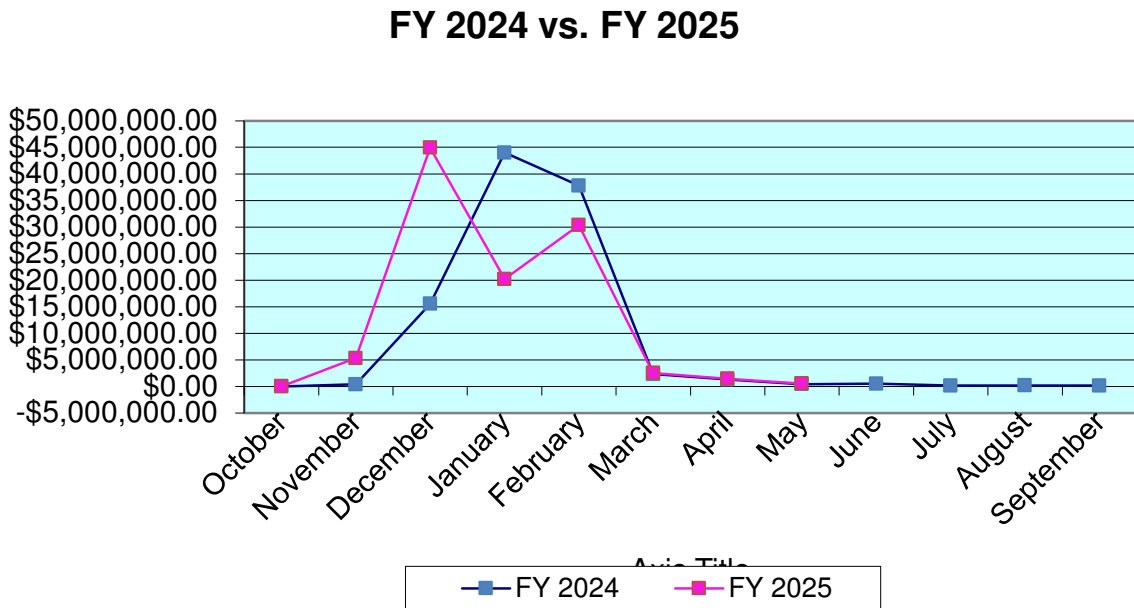
