Addendum #2 ITB 250705 GASOLINE & DIESEL FUELS - ANNUAL PRICING

The following has been incorporated into ITB 250705:

1. The bid minimum specifications have been revised from On-Road Diesel – Dyed or Clear #2, Ultra Low 15 PPM Sulfur 3 to On-Road Diesel – Clear #2, Ultra Low 15 PPM Sulfur 3.

The following is provided in response to questions submitted:

1. May a vendor only offer on delivered loads and not the rack purchases with the service trucks?

Answer: Yes. Just do a no bid for pickup.

2. Has the Lubbock County service trucks ever loaded at the Pro Petroleum terminal?

Answer: The County has not been allowed at the terminal.

3. Are the diesel tanks at the Facilities location delivered via tankwagon? Identify which Transport delivery tanks are above ground and require a pump.

Answer: All of the County's tanks are above ground and can have either a wagon or transport delivered to them.

4. Are the locations (off road) Idalou, Shallowater and Slaton delivered via transport delivery or tankwagon? Are they typically split deliveries?

Answer: Can have either a wagon or transport delivered to them. The logistics for delivery is completely up to the vendor.

5. How often are the generators refueled, absent an emergency?

Answer: Once a year.

6. Please confirm that the gasoline requested is non ethanol conventional gasoline.

Answer: Gasoline may contain ethanol. Per bid specifications, gasoline must be Unleaded 86 octane (excludes unleaded plus & super unleaded).

7. Vendors may not supply an OPIS report to a non-subscribed user due to copyright laws. Will the County accept a daily price notification referencing the index number and pricing? As invoices are automated, and electronic, a copy of published document may not be included in an emailed invoice delivery.

Answer: Lubbock County is a subscriber for OPIS reporting. No, Lubbock County will not accept a daily price notification, referencing the index number and pricing. Per bid specifications, the vendor will need to include a copy of the OPIS daily average standard rack report.

8. Is the County utilizing the 10AM or 5PM OPIS Daily Average Gross?

Answer: The time of the recorded OPIS Daily Average is 10:00 AM.

9. Per the product requirements, On Road Diesel is listed as dyed or clear. Please clarify that the County is utilizing dyed diesel on road.

Answer: The bid minimum specifications have been revised from On-Road Diesel – Dyed or Clear #2, Ultra Low 15 PPM Sulfur 3 to On-Road Diesel – Clear #2, Ultra Low 15 PPM Sulfur 3, per this Addendum #2.

10. As the other vendor stated in the first Q&A, OPIS is a copyrighted product. We are unable to provide this data outside of our company. Will the County please remove the requirement to provide OPIS reports with invoices?

Answer: Please refer to question #3 on Addendum #1 and question #7 on this Addendum #2.

11. Will the County pay by County-initiated ACH?

Answer: Yes. The County can pay by check or ACH/EFT.

12. Will the County accept Net 10 payment terms? If not, what are the standard terms?

Answer: The County is Net 30 terms in accordance with Texas Government Code §2251.
