- 1. How many times in the last year did the county request samples of gasoline and diesel fuel?

  Answer: Twice
- 2. On page 11 under Fuel Types and Locations, The Service Trucks listed, is that for the fuel pick up portion of the bid?

Answer: Yes, the service truck will pick up off-road diesel at the vendor's location.

3. Can you provide the address of "Lubbock County Facilities" for the fourth diesel fuel location?

Answer: Lubbock County Facilities refers to the locations listed. There is not a 4<sup>th</sup> diesel fuel location.

- 4. How often do the generator locations receive fuel deliveries?

  Answer: Once a year.
- 5. What is the average delivery size for Lubbock County Facilities Location? **Answer: 1,000 gallons.**
- 6. Would the County please consider updating bid table to allow for a separate cost to deliver to the generator locations?

Answer: Lubbock County will only consider the Bid Table identified in the ITB.

7. Do the generator locations receive clear diesel or dyed diesel?

Answer: Dyed diesel

- 8. What is the anticipated award date of this contract?

  Answer: Orders from this ITB will start 10/01/2025.
- 9. When do the current fuel contracts expire?

Answer: 09/30/2025

10. In the 2024 bid is it notated that multiple awards were made to Walker Sims Oil, Atlantic Petroleum and All Star Fuel. Can you please indicate which awarded vendor is currently making deliveries for each of the products listed e.g. Dyed Diesel, Unleaded, Clear Diesel, Pick up Off road?

Answer: Walker Sims.

11. Will there be an opportunity to listen to bid opening via Zoom, Teams, conference call, etc.?

Answer: We do not broadcast bid openings via Zoom, Teams or conference call.

12. When will the bid be awarded?

Answer: The bid is anticipated to be awarded at the September 8, 2025 Commissioner's Court.

13. How will successful bidder be notified?

Answer: Successful bidder will be notified via email, and the Bid summary will be posted on the Lubbock County website under Current Bid Opportunities.

14. When will bid tabulations be provided?

Answer: Bid tabulations will be provided once the Bid has been reviewed and approved by the Commissioner's Court.

15. Will any tanks require special fittings for successful delivery?

Answer: No special fittings required.

16. What is the average order size by fuel type/location?

Answer: Average is 1,000 for on and off-road diesel. Unleaded 400.

17. What is the cetane minimum for diesel?

Answer: Between 45-55.

18. Is biodiesel acceptable or forbidden? Answer: Biodiesel is acceptable.

19. Is any type of additive required?

Answer: No additives.

20. Are common carriers considered subcontractors?

Answer: No

21. Is subcontracting allowed?

Answer: Yes, as long as deliveries are consistent.

22. Please confirm that the diesel generators require dyed diesel.

Answer: Yes, dyed diesel for generators.

23. Regarding the Lubbock County Facilities on-road diesel tanks, what is the location of the 3,000 and 11,050 tanks?

Answer: Those are totals from the listed facilities identified in the table Lubbock County Emergency Generators fueled by diesel, along with the listed Delivery Locations.
