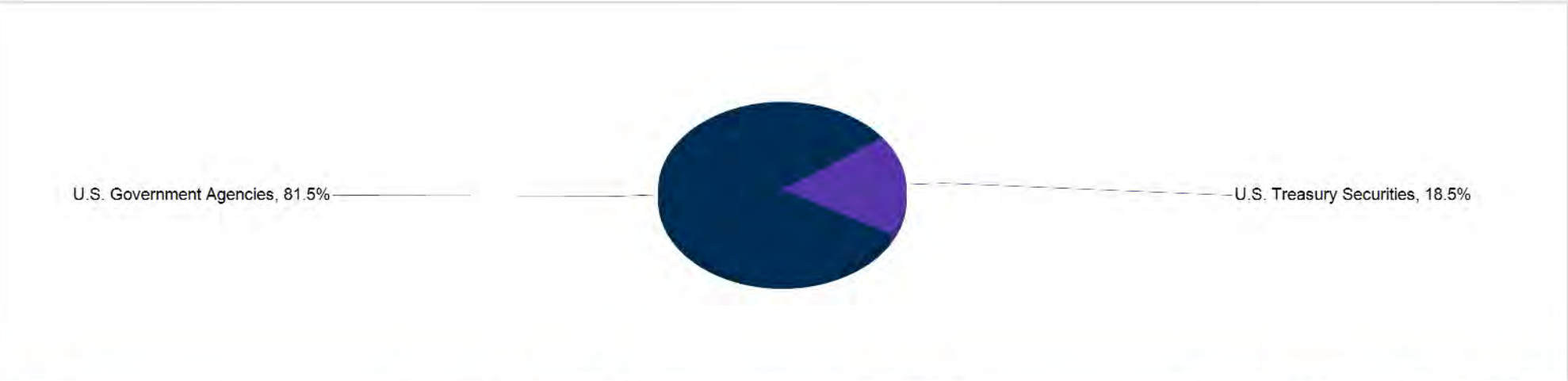

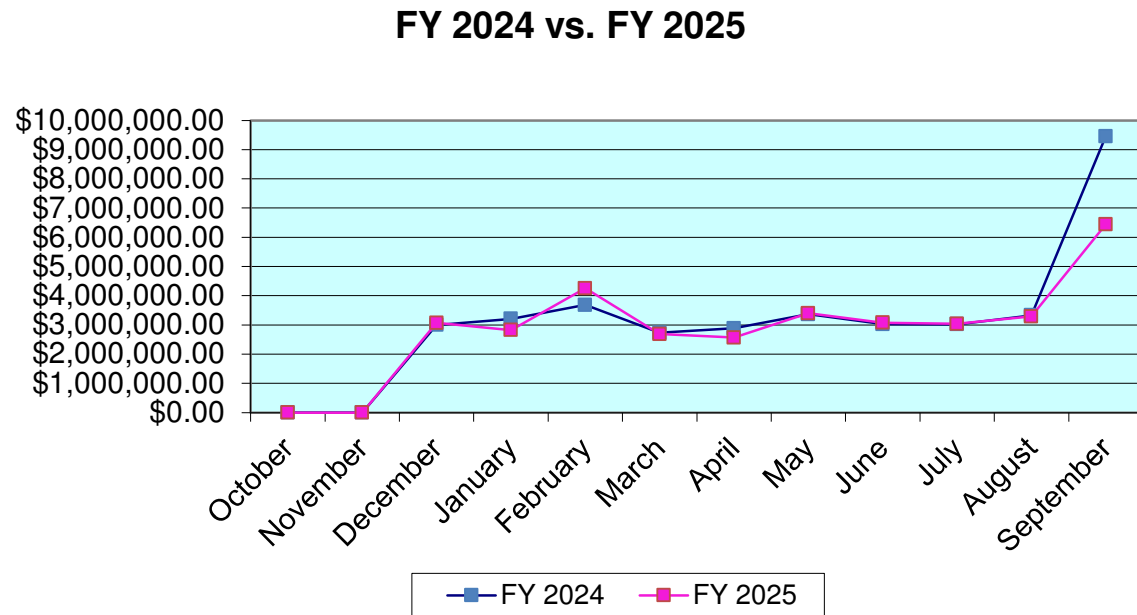

As of September 2025

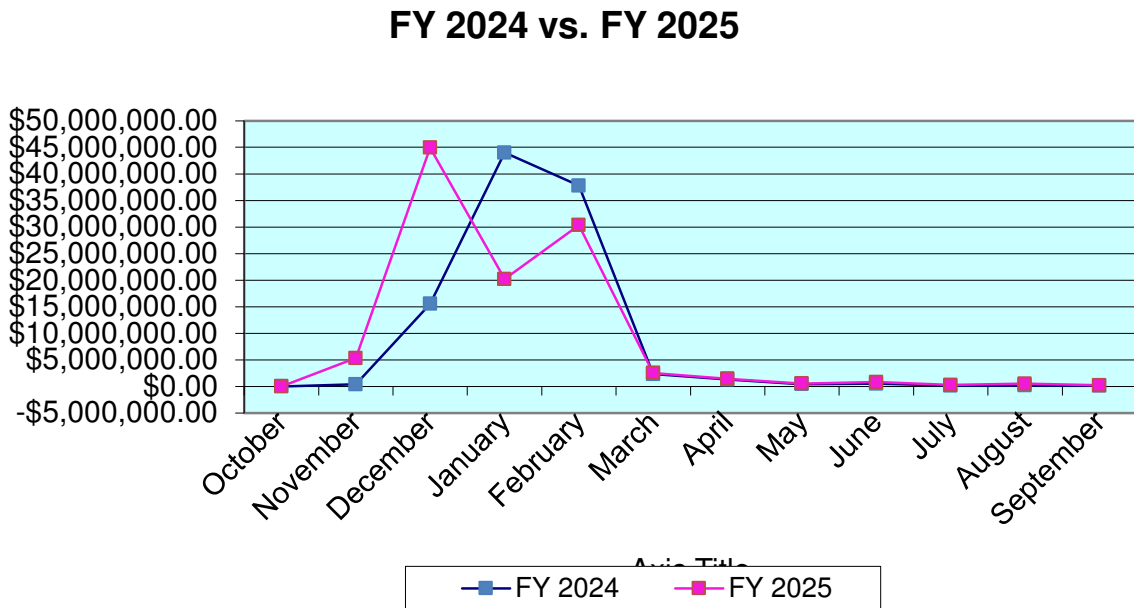
