- 8. Financial update from the Lubbock County Auditor's office Kathy Williams presented a Financial update. The Venue Fund YTD Fund Balance is at \$14,503,856 as of 11/12/25. There are no changes in the Debt Service or Construction Funds.
- 9. Update from Greg Garfield (Garfield Public Private), Randy Jordan (Lubbock County Expo Center, Inc.) and others regarding the Project. Greg presented a slide presentation that outlined the progress of the Project. The revised plan that works and makes sense is a project that is similar to the Taylor County Telecom Arena. It meets the needs of the project, is more economical and has an estimated cost of \$66,900,000. Randy stated that with an interim line of construction credit and a \$20,000,000 loan commitment, we now have a fully funded project. Greg reviewed the Development Budget, Pro-Forma, Sources and Uses of Funds and the Preliminary Project Schedule. There was much discussion, and a number of questions were raised.
