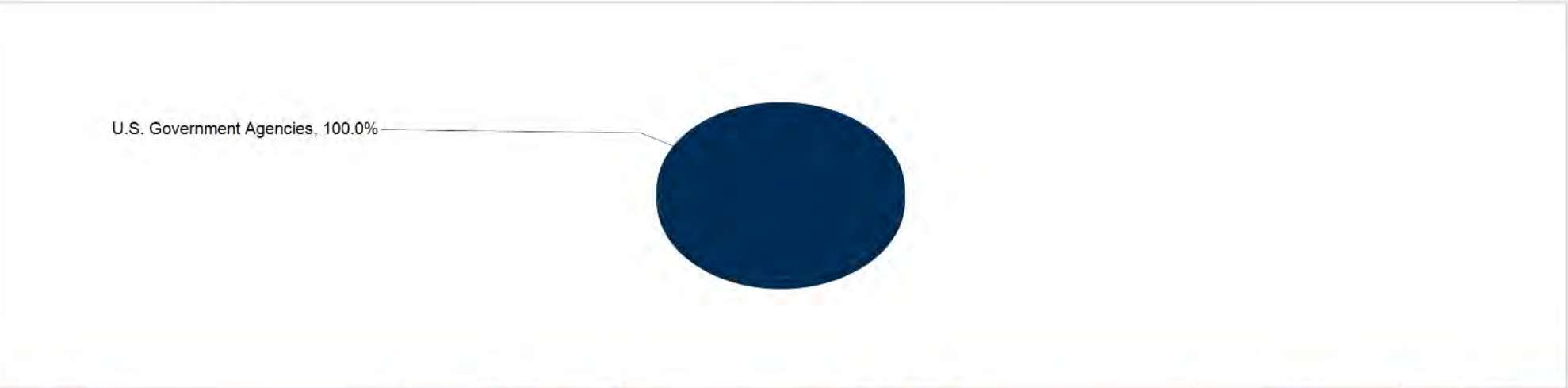

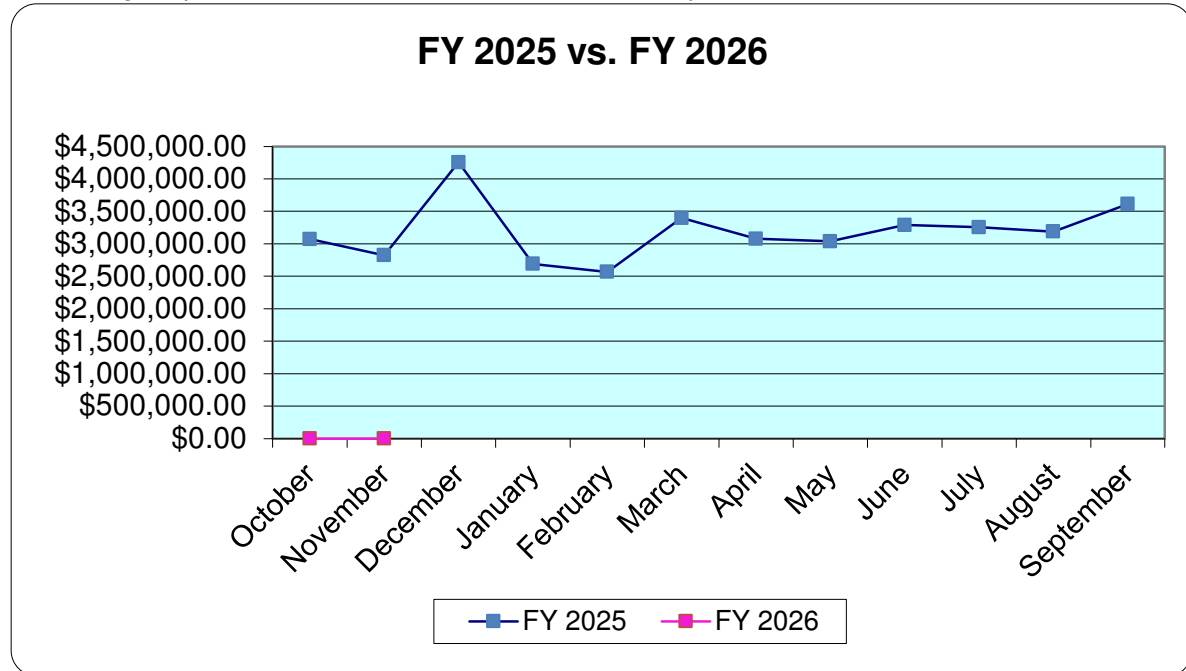

As of November 2025

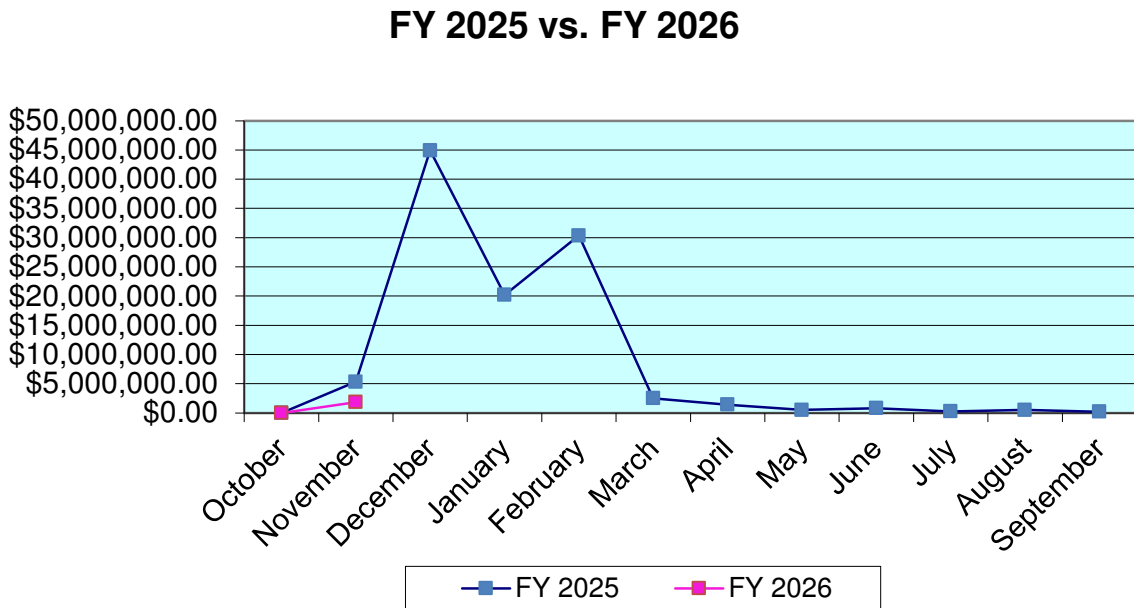
