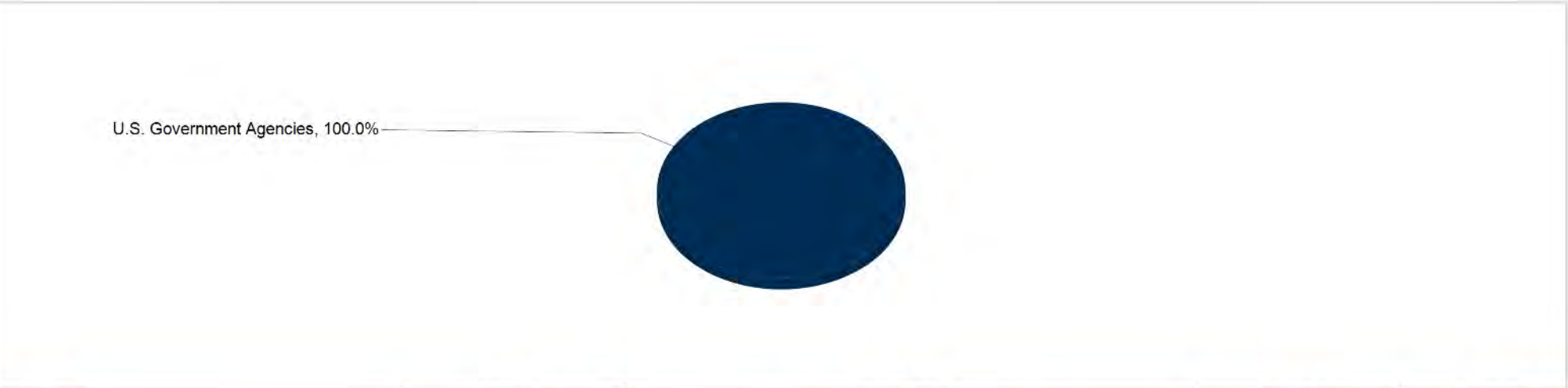

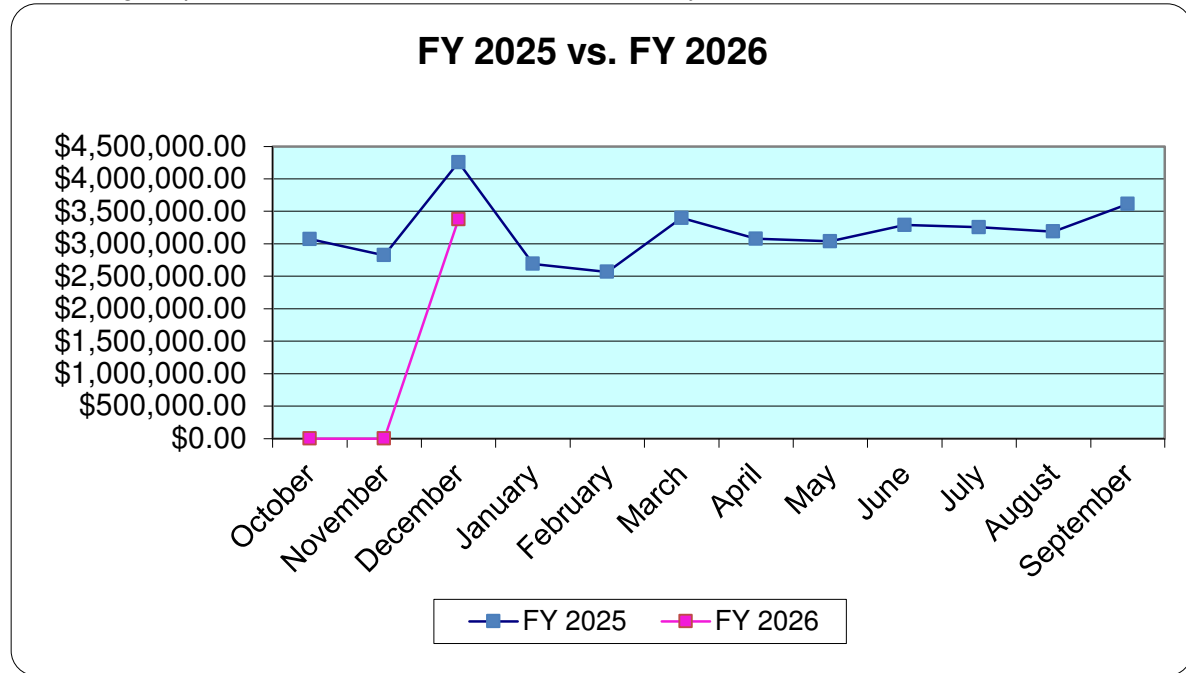

As of December 2025

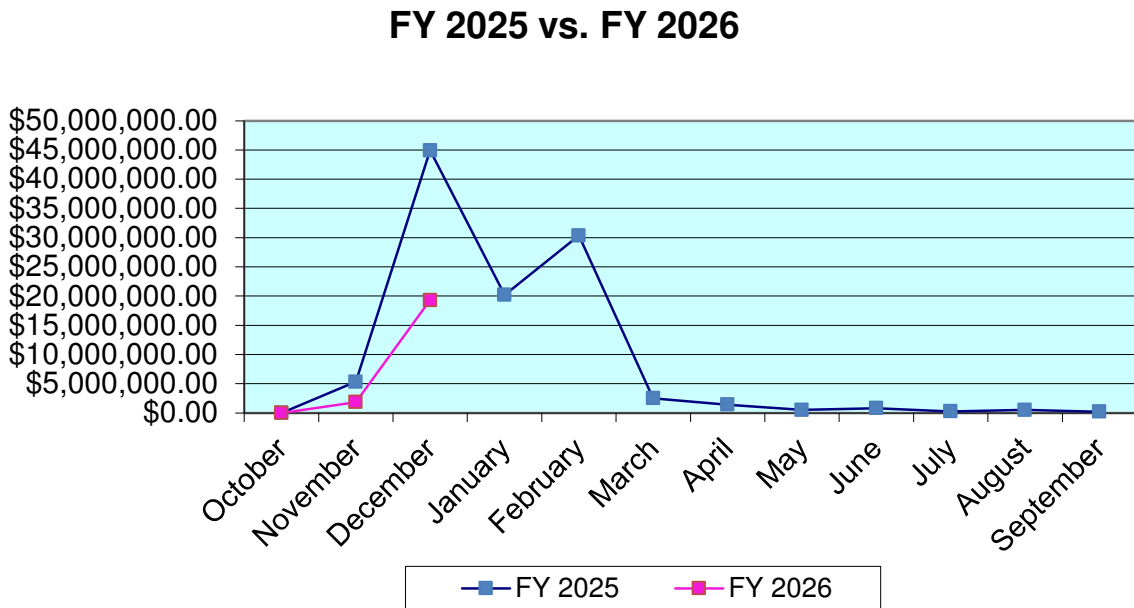
