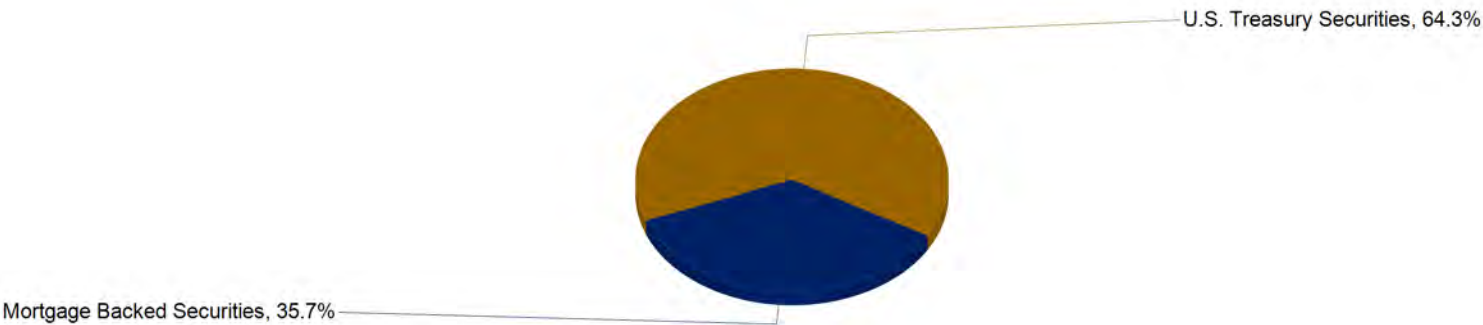

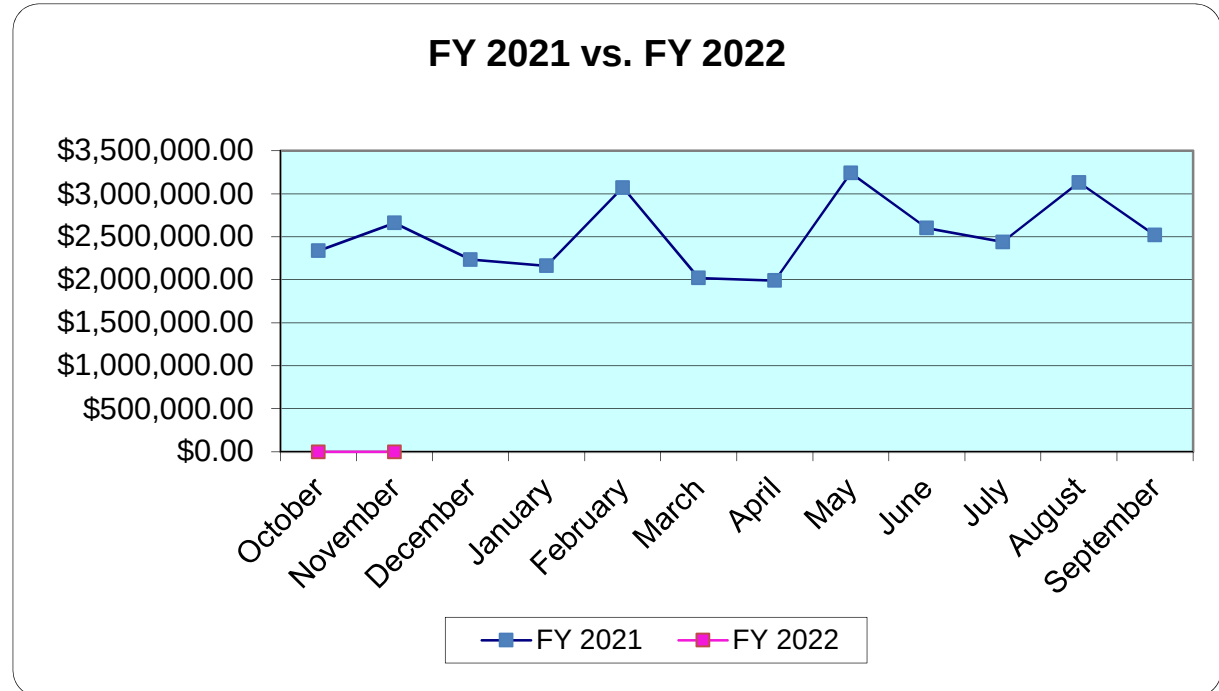

As of November 2021

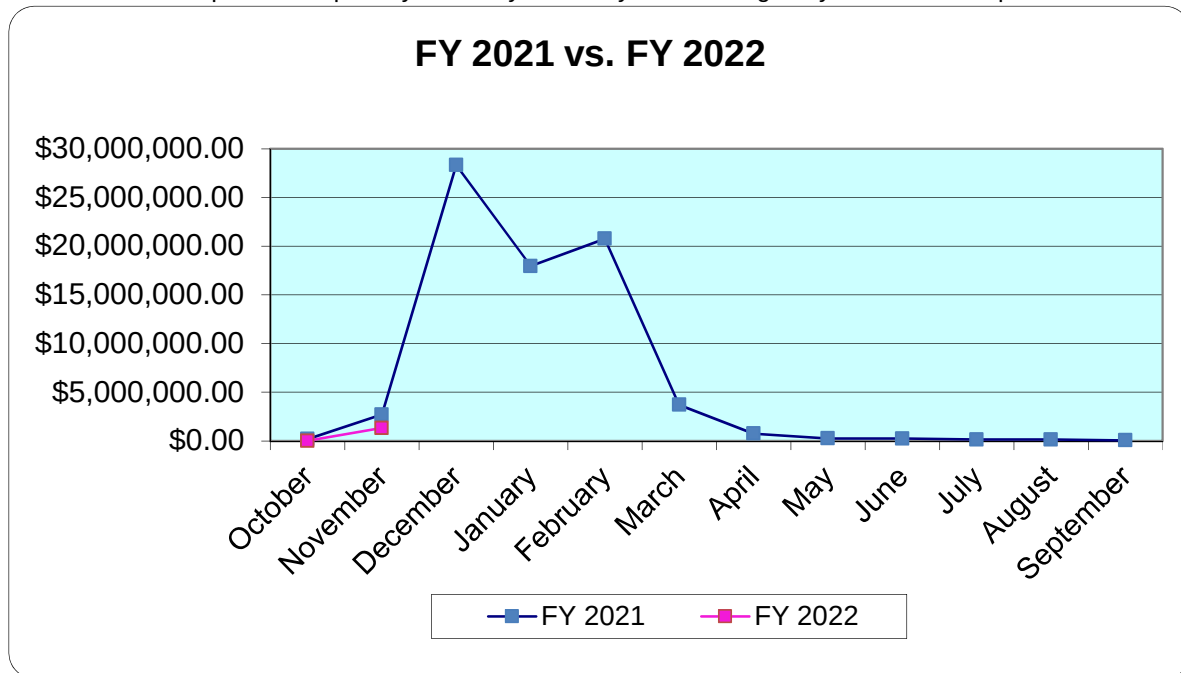
