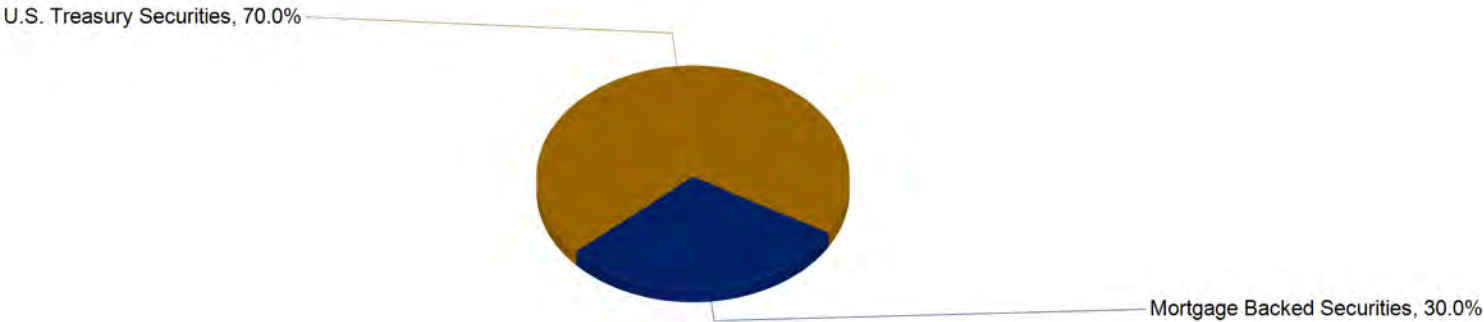

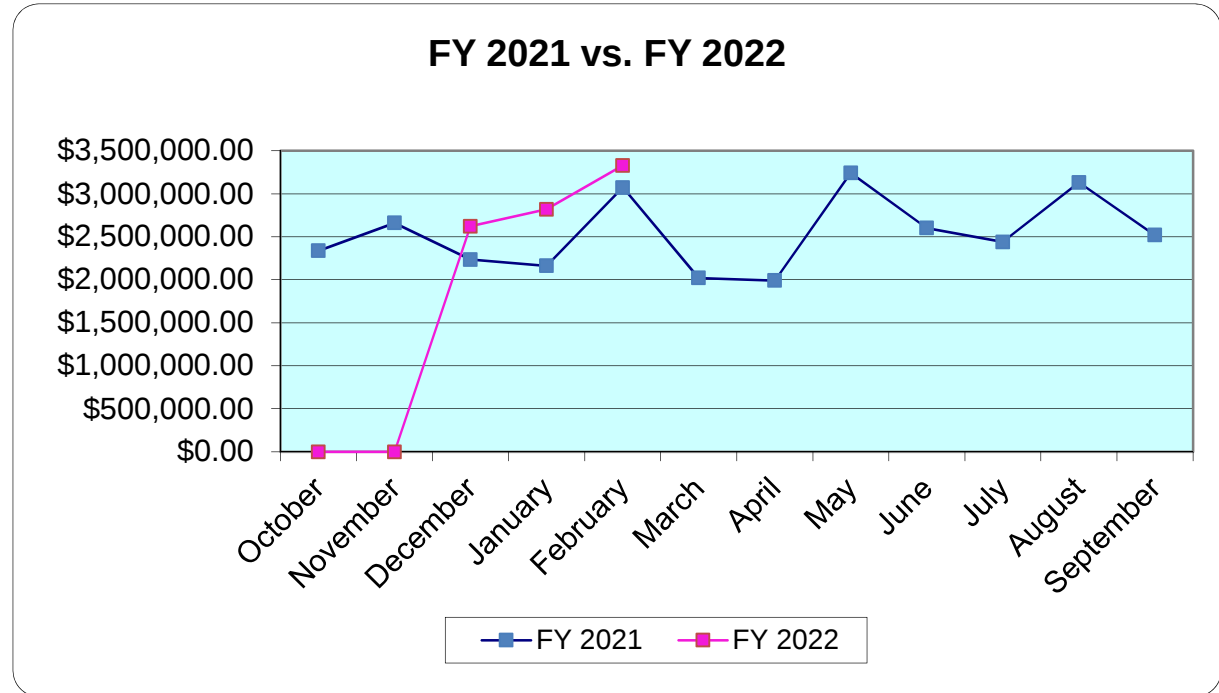

As of February 2022

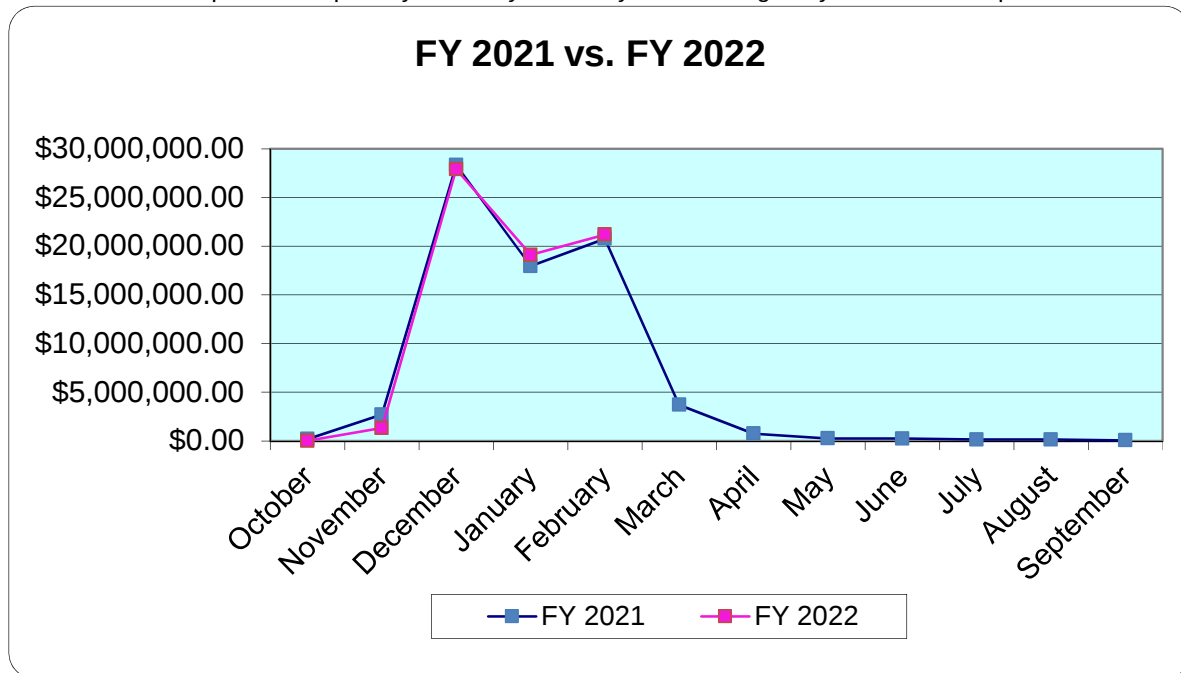
