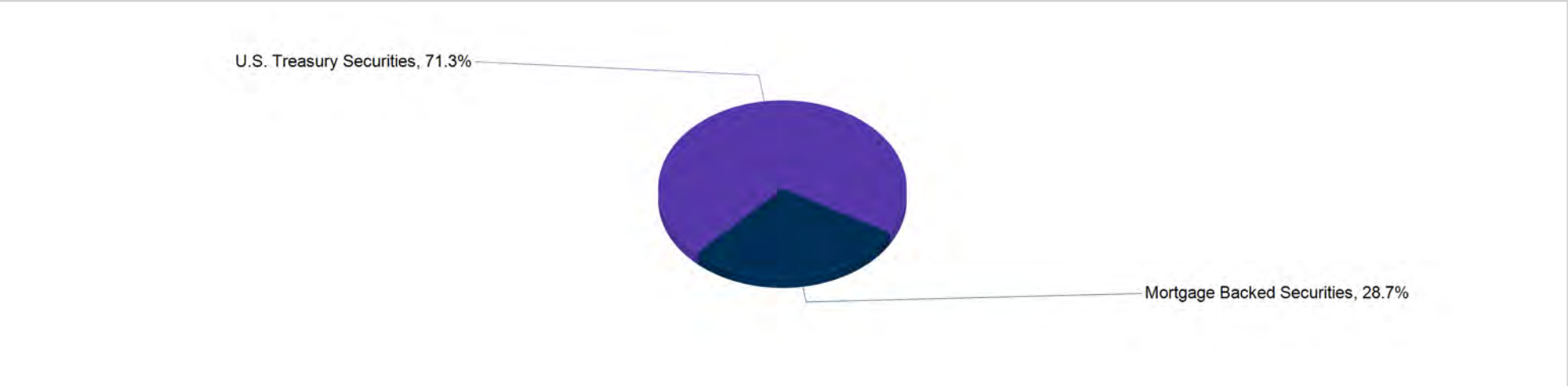

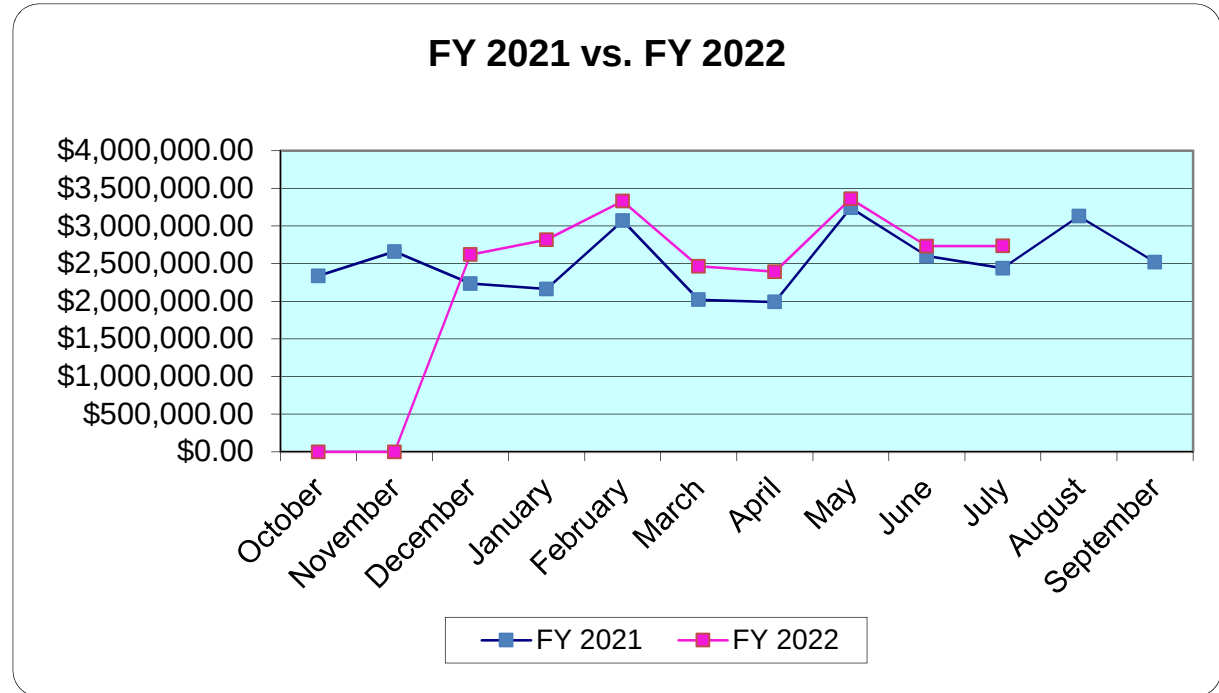

As of July 2022

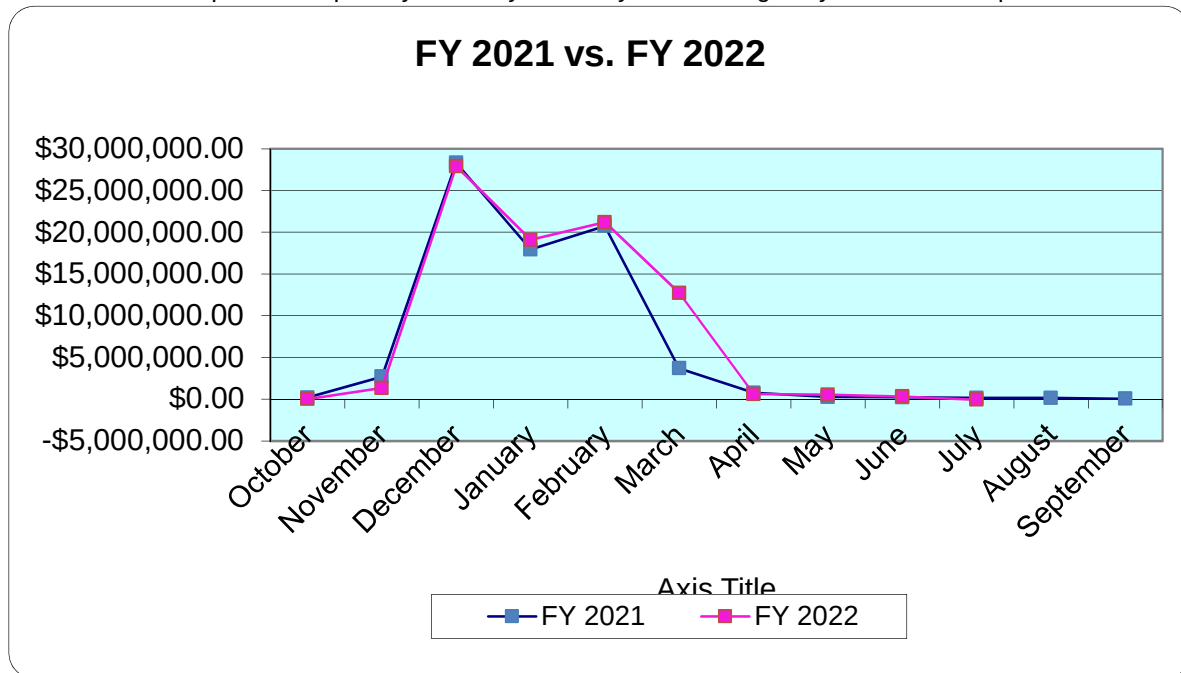
