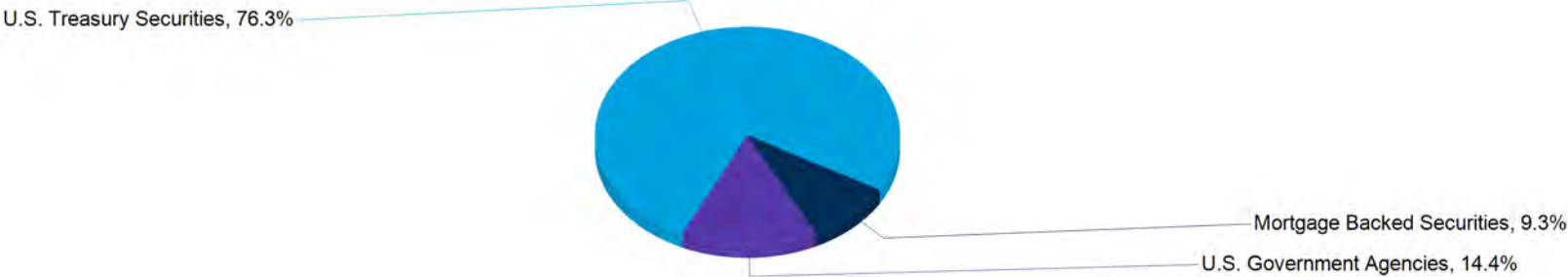

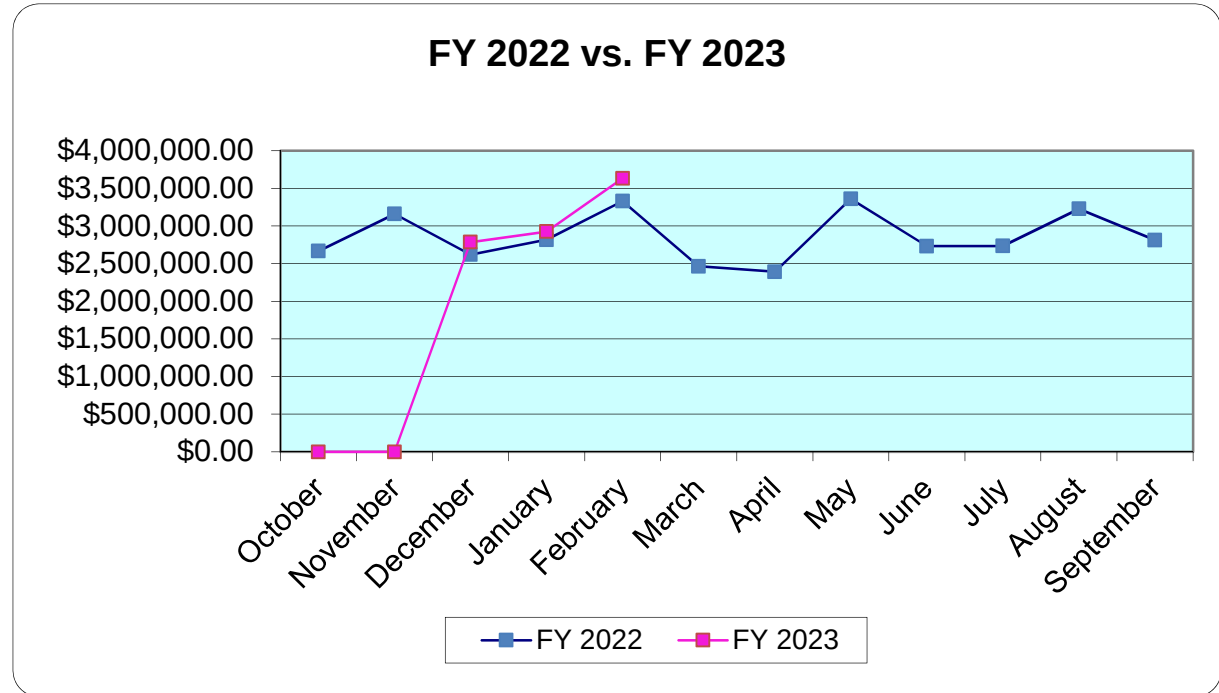

As of February 2023

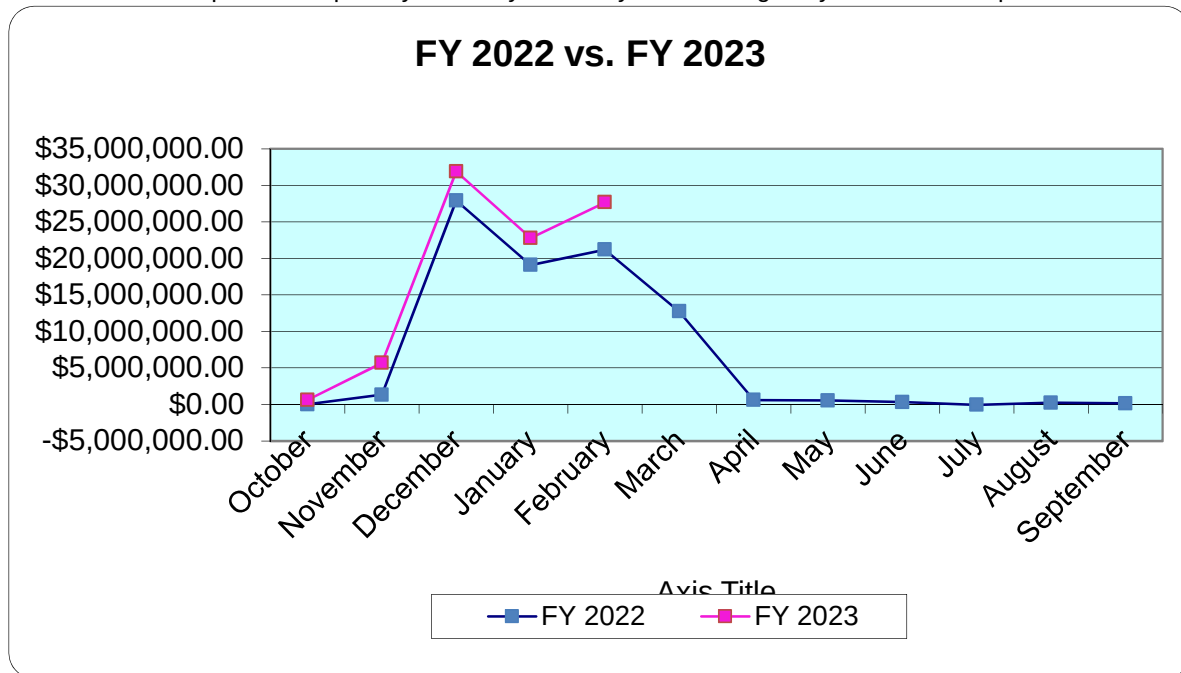
