NOTICE OF BOND ELECTION

TO THE RESIDENT, QUALIFIED VOTERS OF LUBBOCK COUNTY:

AN ORDER BY THE COMMISSIONERS COURT OF LUBBOCK COUNTY, TEXAS CALLING A BOND ELECTION TO BE HELD WITHIN SAID COUNTY, MAKING PROVISION FOR THE CONDUCT OF THE ELECTION AND RESOLVING OTHER MATTERS INCIDENT AND RELATED TO THE HOLDING OF SUCH ELECTION

WHEREAS, the Commissioners Court of Lubbock County, Texas hereby finds that an election should be held to determine whether said governing body shall be authorized to issue bonds of said County in the amount and for the purpose hereinafter identified; and

WHEREAS, Chapter 271 of the Texas Election Code provides for joint elections when an election is required upon the same day by two or more political subdivisions occupying all or a part of the same territory.

THEREFORE, BE IT ORDERED, ADJUDGED AND DECREED BY THE COMMISSIONERS COURT OF LUBBOCK COUNTY, TEXAS:

<u>SECTION 1</u>: An election shall be held on the 4th day of May, 2019, in Lubbock County, Texas, which date is seventy-eight (78) or more days from the date of the adoption of this order (the "Order") within and throughout the territory of the County at which all resident, qualified electors of the County shall be entitled to vote, and is not less than fifteen (15) nor more than ninety (90) days from the date of the adoption hereof. At such election, the following measures shall be submitted:

PROPOSITION

"SHALL the Commissioners Court of Lubbock County, Texas be authorized to issue bonds of the County under the authority of Article III, Section 52 of the Texas Constitution, in one or more series or issues, in an amount not to exceed the aggregate principal amount of \$99,650,000 for the purpose of providing funds for permanent public improvements, to-wit: construction, maintenance, and operation of macadamized, graveled or paved roads and turnpikes, or in aid thereof, throughout the County, said bonds of each series or issue, respectively, to mature serially over a period of not to exceed thirty (30) years from their date, and to be sold at such price or prices and to bear interest at such rate or rates as shall be determined within the discretion of the Commissioners Court at the time

of issuance; and to provide for the payment of the principal of and interest on said bonds by levying and collecting annual ad valorem taxes upon all taxable property within the County in an amount sufficient to pay the annual interest on said bonds and to provide a sinking fund sufficient to pay said bonds as they become due?"

<u>SECTION 2</u>: An electronic voting system, as defined and described in Title 8 of the Texas Election Code, shall be utilized for the Election and ballots shall be prepared in accordance with the Texas Election Code so as to permit the electors to vote "FOR" or "AGAINST" the aforesaid measure which shall appear on the ballot substantially as follows:

PROPOSITION

[] FOR

"THE ISSUANCE OF ROAD TAX BONDS IN AN AMOUNT NOT TO EXCEED \$99,650,000 FOR ROAD CONSTRUCTION AND IMPROVEMENTS WITHIN LUBBOCK COUNTY."

[] AGAINST

SECTION 3: The presently existing boundaries and territory of the respective Lubbock County Election Precincts shall be utilized for this election. The polling places and officials duly designated by the County for each precinct as well as the duly designated Presiding Judge of the Early Voting Board, the Presiding Judge at the Central Counting Station, the Manager at the Central Counting Station and the Central Counting Station Supervisor shall serve for the election.

To the extent appropriate this Election may be held as a joint election pursuant to Chapter 271, Texas Election Code. The Joint Election Resolution for this Election is attached to this Order as EXHIBIT "A" and is incorporated by reference as if fully set out in the body of this Order.

On election day, the polls shall be open from 7:00 a.m. to 7:00 p.m. The polling locations for election day are attached to this Order as EXHIBIT "B" and are incorporated by reference as if fully set out in the body of this Order.

<u>SECTION 4</u>: <u>Early Voting</u>. The Early Voting Clerk for all purposes shall be the County Elections Administrator, Dorothy Kennedy. The Early Voting Clerk may appoint Deputy Early Voting Clerks to assist with the duties of early voting.

Early Voting by Personal Appearance

Early Voting by personal appearance shall be conducted at the main early voting location listed below in accordance with the provisions of the Texas Election Code. All other branch and/or temporary early voting locations, along with dates and times for early voting at those locations are attached to this Order as EXHIBIT "C" and are incorporated by reference as if fully set out in the body of this Order.

The period to apply for a ballot by mail is January 1, 2019 through April 23, 2019. The application must be received by April 23, 2019 (mere postmarking by the deadline is insufficient).

For the use of those voters who are entitled by law to vote early by mail, the early voting clerk shall provide each voter with a ballot with instructions to mark the ballot indicating his or her vote(s) on the same ballots utilized for early voting by personal appearance at the Election.

SECTION 5: All resident qualified electors of the County shall be permitted to vote at said election, and on the day of the election, such electors shall vote at any vote center established within the County. This election shall be held and conducted in accordance with the Texas Election Code and Chapter 1251, Texas Government Code, and as may otherwise be required by law, all election materials and proceedings shall be printed in both English and Spanish.

SECTION 6: The Custodian of Records appointed by the Commissioners Court shall be responsible for the preparation of notices, instructions, orders, ballots and other written material pertaining to the election and shall cause each such document to be translated into and furnished to voters in both the English language and the Spanish language in order to aid and assist voters speaking Spanish as a primary or an alternative language to properly participate in the election process. In addition, the Custodian is hereby authorized and directed to make available to the voters having the need of an individual capable of acting as a translator and speaking both English and Spanish languages who will assist Spanish speaking voters in understanding and participating in the election process.

SECTION 7: The Commissioners Court appoints Dorothy Kennedy, the Lubbock County Elections Administrator as the Custodian of Records ("Custodian") to perform the duties related to the conduct and maintenance of records of the election as required under the Texas Election Code during the period beginning the third (3rd) day after the approval of this Order calling the Bond Election and ending not earlier than the fortieth (40th) day after the day of the Election. In particular, the Custodian accepts and maintains records regarding campaign expenditures that may be filed with the County.

The Custodian shall maintain an office open for election duties for at least three hours each day, during regular office hours, on regular business days during the period designated in this section. This office shall be located at 1308 Crickets Avenue, Lubbock, TX 79401.

The Custodian shall post notice of the location and hours of the Lubbock County Tax Assessor's Office as required by the Texas Election Code. The Custodian shall maintain in the Tax Assessor's Office the documents, records and other items relating to the election and shall be the person designated to receive documents on behalf of the County that are required by the Texas Election Code. Dorothy Kennedy shall also serve as Custodian for the sole purpose of preserving all voted ballots securely in a locked room in the locked ballot boxes for the period for preservation required by the Election Code.

SECTION 8: (a) A substantially complete copy of this Order shall serve as proper notice of said election. Said notice, including a Spanish translation thereof, shall be published on the same day in each of two successive weeks in a newspaper of general circulation in said County, the first of said publications to appear in said newspaper not more than thirty (30) days and not less than fourteen (14) full days prior to the day of the election.

- (b) Notice of the Election, containing a substantial copy of this Order, in both the English and Spanish languages, shall also be posted on the bulletin board used by the County to post notices of Commissioners Court meetings.
- (c) A copy of this Order, in both the English and Spanish languages, shall be posted (i) in a prominent location at each polling place on Election Day and during early voting by personal appearance, (ii) at three (3) other public places within the County, (iii) at the County Courthouse; and (iv) on the County's website, prominently and together with the notice of the election and the contents of the proposition, no later than the twenty-first (21st) day before the Election.

<u>SECTION 9</u>: The following information is provided in accordance with the provisions of Section 3.009(b), Texas Election Code.

- (a) The Proposition language that will appear on the ballot is set forth in Section 1 hereof.
- (b) The purpose for which the bonds are to be authorized is set forth in Sections 1 and 2 hereof.
 - (c) The principal amount of the debt obligations to be authorized is \$99,650,000.

- (d) Taxes sufficient to pay the annual principal of and interest on the general obligation bonds may be imposed.
- (e) The County intends to issue the bonds authorized by the Proposition over a period of years in a manner and in accordance with a schedule to be determined by the Commissioners Court based upon a number of factors, including, but not limited to, the then current needs of the County, demographic changes, prevailing market conditions, assessed valuations in the County and management of the County's short-term and long-term interest rate exposure. Market conditions, demographics and assessed valuations vary based upon a number of factors beyond the County's control, and therefore, the County cannot and does not guarantee a particular interest rate or tax rate associated with the bonds authorized by the Proposition. As such, the information contained in this paragraph is provided solely for illustrative purposes and does not establish any limitations or restrictions or create a contract with the voters. The County currently estimates that, if the Proposition were approved and the bonds proposed herein were authorized and issued in accordance with the County's current estimated project plan of finance, the maximum interest rate of the bonds is not expected to exceed four percent (4.00%).
- (f) If the bonds are approved, they may be issued in one or more series, to mature serially, over a period not to exceed twenty-five (25) years from the date of issuance of each series of bonds.
- (g) The County, as of its fiscal year beginning January 1, 2019 had outstanding and aggregate ad valorem tax-supported principal amount of debt equal to \$32,550,000.
- (h) The aggregate amount of the interest owed on such County debt obligations, through respective maturity, totaled \$4,222,325.
- (i) The County levied an ad valorem debt service tax rate for its outstanding debt obligations of \$0.039329 per \$100 of taxable assessed valuation.

If a majority of the resident, qualified electors of the County voting at the Election, including those voting early, shall vote in favor of the Proposition, then the issuance and sale of the bonds shall be authorized in the maximum respective amount contained therein, and the general obligation bonds shall be issued and sold at the price or prices and in such denominations determined by the Commissioners Court to be in the County's best interests.

<u>SECTION 10</u>. <u>Authority of the County Judge</u>. The County Judge of the County shall have the authority to take, or cause to be taken, all actions reasonable and necessary to ensure that the Election is fairly held and returns properly counted and tabulated for canvass by the Court, which actions are hereby ratified and confirmed.

SECTION 11. Severability. If any provision of this Order or the application thereof to any person or circumstance shall be held to be invalid, the remainder of this Order and the application of such provision to other persons and circumstances shall nevertheless be valid, and the Court hereby declares that this Order would have been enacted without such invalid provision.

SECTION 12. Notice of Meeting. The Court officially finds, determines, recites and declares that written notice of the date, hour, place and subject of the meeting at which this Order is adopted was posted on a bulletin board located at a place convenient to the public at the County's Courthouse for at least 72 hours preceding the scheduled time of the meeting; that a telephonic or telegraphic notice of such meeting was given to all news media who have consented to pay any and all expenses incurred by the County in connection with providing such notice, both as required by the Open Meetings Law, Chapter 551, Texas Government Code, as amended; and that such meeting was open to the public as required by law at all times during which this Order and the subject matter thereof was discussed, considered and formally acted upon.

SECTION 13. Authorization to Execute. The County Judge is authorized to execute and the County Clerk is authorized to attest this Order on behalf of the Court; and the County Judge is authorized to do all other things legal and necessary in connection with the holding and consummation of the Election.

WHEREAS, Chapter 271 of the Texas Election Code provides for joint elections when an election is required upon the same day by two or more political subdivisions occupying all or a part of the same territory; and

WHEREAS, several other political subdivisions within Lubbock County also are conducting elections on the same day and are also contracting with the Lubbock County election official for election services; and

WHEREAS, Lubbock County, Texas desires to contract with the various and several political subdivisions located within the county for joint election services for the special election on **May 4, 2019**; and

WHEREAS, the various and several political subdivisions, within Lubbock County, Texas (and including, as appropriate, the contiguous counties of Hale, Hockley, Lynn and Garza, County, Texas) desire to conduct joint elections on **May 4, 2019**, with all such governmental units as are eligible and desire to conduct a joint election as may be expressed by order, resolution or other official action of said governmental units including, but not limited to: Lubbock County, Texas; Village of Buffalo Springs; Town of Ransom Canyon; City of Slaton; City of Idalou; City of Abernathy; City of New Deal; City of Wolfforth; City of Shallowater; City of Lubbock; the Lubbock County Water Control and Improvement District, No. 1; High Plains Underground Water Conservation District No. 1; Shallowater ISD; Slaton ISD; New Deal ISD; Idalou ISD; Roosevelt ISD; Lubbock-Cooper ISD; Frenship ISD; Lubbock ISD; Abernathy ISD; Southland ISD and any other eligible governmental entity which shares territory in Lubbock County, Texas with one or more of the school districts or municipalities in the county.

NOW, THEREFORE BE IT RESOLVED BY THE COMMISSIONERS COURT OF LUBBOCK COUNTY, TEXAS:

THAT the Commissioners Court of Lubbock County, Texas hereby authorizes and directs the Lubbock County Elections Administrator to conduct a joint election with any other eligible governmental entity which shares territory in Lubbock County, Texas for the **May 4, 2019** Election; and

THAT the Elections Administrator is hereby authorized and directed to take any and all actions as may be necessary to carry out the purposes of this Resolution.
